9 GENERAL BUSINESS

9.1 Autocross

Significant discussion over the safety of the crossover and whether a physical barrier needs to be installed to prevent cars crossing over instead of completing the flying finish on their last lap. The crossover is highlighted during the Driver's Briefing but this has not avoided a

number of incidents in 2013. The drivers are ultimately responsible for completing the course correctly. The last lap boards were considered ineffective in any location where an official could be positioned and are not part of the track licence. Bob Nicoli offered to develop a barrier design for Committee review if a budget was proposed.

- Track widening over the past few years, the track has widened significantly allowing faster speeds. Installation of partially buried tyres heading into corners to be considered to define the track edges.
- SOS lights concerns raised during the year that the steady yellow LED lights are difficult to see and are not in the driver's line of sight approaching the corners. Light type and location to be reviewed (original SOS poinst were dictated by officials safety).
- Timing system a few minor issues to resolve with communications to the flying finish beams. Connectivity of the timing unit to a computer to automatically input results to be followed up.
- Proposal for a State Series with BORMSA, SWTCC and WACC. Other clubs to be approached to gauge interest.
- Proposal to approach junior sedans or speedway competitors to boost entry numbers at BORMSA – there may be compliance issues with cars. Input required from scrutineers before considering further.
- Entry forms suggested to add clarity in the Supp Regs and event emails that day memberships are welcomed for the autocross events ("club only" is for permit costs and ambulance requirements and is not intended to discourage entries).

9.2 Khanacross

- Low competitor numbers in 2013.
- As per the proposed 2014 Calendar, the intention is to reduce the number of events in 2014 to allow the tracks to be worked on.
- Only 6 tracks are fit for use at the moment.

9.3 Entries

Entries are to be continued to be limited to 40 for Khanacrosses (multi-club) and Autocrosses (club only). Junior Motorkhanas and Driver Developments days remain unchanged at a 20 entry limit.

9.4 Calendar for 2014

9.5 Fees

The following fee structure was unanimously agreed to for 2014 (assuming no increase in CAMS permit fees):

Entries will continue to close the Thursday prior to events to allow confirmation of sufficient entries to run the event and for catering purposes. The Event Secretary generally accommodates all last minute entries if the event is on.

Contributing Office Bearers and Committee members will receive complimentary membership.

9.6 Track Hire

Track hire of the khanacross tracks will be restricted in 2014 as part of efforts to rebuild and improve the tracks. Any track hire will be at Committee discretion but would be based on the previous years' fee structure:

Track hire (commercial events)	\$800/day (limit of 10 cars)
Track hire (long term club members 3 years+)	\$200 + \$100 per additional vehicle
Track hire (non members & club members less than 3 years)	\$300 + \$150 per additional vehicle
Track hire (other clubs, khanacross event)	\$10/car
Track hire (other clubs, motorkhana event)	\$5/car

Track hire of the autocross tracks is agreed in concept if the appropriate provisions (eg. bond payment and suitable fee structure) could be agreed to ensure sufficient monies were available to rectify the tracks for Club events if any significant damage were to occur. Use of road tyres, numbers of cars, etc to be considered in the evaluation.

9.7 Newsletter, Website & Facebook

Newsletters issued throughout 2013 by Cheryl Simson, Ash Burton's offer to publish newsletters in 2014 is gratefully accepted.

BORMSA website operating smoothly apart for some downtime during the year. Website hosting will remain unchanged in 2014 due to the 2-year fee paid.

BORMSA Facebook page has been created and is being used for promoting events, issuing newsletters and posting event photos. A BORMSA group is also on Facebook providing a forum for discussions.

9.8 Club Championship

Points structure for 2014 will remain as per 2013. To be eligible for club championship points, drivers must be BORMSA members, have competed in a minimum of 2 events and, apart from juniors, must have officiated or assisted in running an event to be eligible for the club championship.

To reduce trophy costs and based on competitor feedback, a voucher system is proposed for 2014 events. Two vouchers will be awarded at each event – one to the winner and the second as a raffle draw for all competitors and officials. Potential vouchers include fuel, automotive providers, local businesses and BORMSA vouchers (for entries and merchandise). Businesses to be approached to sponsor our events through provision of or discounts for vouchers.

Value suggested to be equivalent to entry fee eg.\$75 for autocross, \$50 for khanacross.
