ARTICLE M3 – VEHICLE ELIGIBILITY

- M3.1 The Competitor (vehicle owner) shall provide written authorisation for the use of the vehicle in competition by the Driver(s) and acceptance of the Terms and Conditions by signing the disclaimer on the reverse of the entry form.
- M3.2 Vehicles shall be presented in a clean condition.
- M3.3 Three different drivers may compete in the same vehicle with different numbers allocated.
- M3.4 Vehicles entered in the Junior Motorkhana are to comply with the current CAMS Manual of Motor Sport, General Requirements for Cars and Drivers Schedule A and Group 4H Regulations. This includes:
- Noise levels (<95dBA) in accordance with Group 4H
 - Fuel in accordance with Schedule G of the current CAMS Manual of Motor Sport.
 - Seat belt/harness in accordance with Schedule I of the current CAMS Manual of Motor Sport (including harness validity dates).

ARTICLE M4 – COMPETITOR ELIGIBILITY

- M4.1 The Event will be a club only activity. Complimentary day memberships are available for any competitors who are not members of BORMSA. All drivers/competitors must be members of a CAMS-affiliated club.
- M4.2 Competitors must hold at least a CAMS Level 2NS or 2NSJ Competition Licence.
- M4.3 The minimum age is 12 years for the Junior Motorkhana.
- M4.4 All competitors shall be suitably attired as per Schedule D of the current CAMS Manual of Motor Sport. This includes:
- Trousers to cover from waist to ankle
 - Suitable enclosed footwear (no thongs, sandals or high heels permitted)
 - Approved helmet fastened correctly (the helmet must comply with AS1698 or one that is specifically approved for use by CAMS and carries the markings to that effect)
 - In open cars, goggles or visors with lens of other than glass (AS1609-1981) must be worn
- M4.5 In addition, competitors shall have:
- Sleeves fastened to reach the wrist
 - Shirts done up from neck to wrist
 - Clothing and footwear of flammable synthetic material is not acceptable

ARTICLE M5 – CLASSES

- M5.1 Competitors will run in a single category for the Junior Motorkhana.

ARTICLE M6 – ENTRY FORM, ENTRIES AND ENTRY FEE

- M6.1 Entries are to be made by using the Entry Form available for download from the BORMSA website at www.bormsa.asn.au.
- M6.2 The number of entries per event will be limited to 20 for the Junior Motorkhana, accepted in order of receipt.
- M6.3 The organiser reserves the right to refuse entry in accordance with NCR 83 of the current CAMS Manual of Motor Sport.
- M6.4 The entry fee for the Junior Motorkhana will be \$20.

ARTICLE M7 – SCRUTINY AND REGISTRATION

- M7.1 Vehicles must be presented for scrutiny at Beverley Off Road Motor Sport complex at the times indicated in Article M2.
- M7.2 All appropriate CAMS Licences, current club membership cards and CAMS vehicle logbooks (if issued) must be produced at Documentation at the times indicated in Article M2.
Note: CAMS licence renewals must be processed through the CAMS office and cannot be renewed on the day. New competitors only may purchase licences on the day.
- M7.3 Drivers will not be allowed to commence the event until their Scrutiny and Documentation is complete.
- M7.4 Competitors are advised that any in-car video or moving film cameras must be installed in the vehicle prior to scrutiny so that the camera and its mounting can be inspected.

ARTICLE M8 – DRIVERS BRIEFING

A compulsory Drivers Briefing will be held as per Article M2. All competitors must be in attendance. Any competitor not in attendance must report to the Clerk of Course. Competitors will be required to have read and understood these Regulations and any further regulations or Advice and seek an Official if any further advice is required.

ARTICLE M9 – RECONNAISSANCE

ARTICLE M10 – RUNNING OF THE EVENT

- M10.1 Only one car is permitted on the test at any one time. Cars will start and finish from the garage in a stationary condition as per the Motorkhana Code diagrams.
- M10.2 Orange cones shall be used as markers throughout.
- M10.3 Timing will be by stopwatch.
- M10.4 Each competitor will have a minimum of 8 timed runs, depending on competitor numbers and if time permits.
- M10.5 Vehicles are limited to walking pace in the vicinity of the pits, caravan and marshalling area at all times. Any individuals who fail to comply shall be referred to the Clerk of Course.

ARTICLE M11 – DETERMINATION OF WINNERS

- M11.1 The cumulative time for all timed runs (inclusive of penalties) in the Junior Motorkhana event will be utilised to determine the winner.
- M11.2 Any protest must be lodged in accordance with Part XII of the NCR. The Chief Timekeeper/Secretary will be the Judge of Fact.
- M11.3 The winner of the Junior Motorkhana event (as determined in M11.1) shall receive a BORMSA voucher to the value of \$20.

ARTICLE M12 – USE OF PROHIBITED SUBSTANCES

During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A and 145B of the CAMS Manual of Motor Sport. In addition, the persons concerned will be subject to the articles of the Standard Operating Procedure for Alcohol Testing, the CAMS Anti-Doping Policy and the CAMS Illicit Drugs in Sport (Safety Testing) Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s). **Other Prohibited Substances:** the CAMS Anti-Doping Policy, as appears in the CAMS Manual of Motor Sport, and as amended from time to time, recognised as an integral component of the NCR and is duly authorised as such. In any areas where the National Competition Rules and the CAMS Anti-Doping Policy conflict, the CAMS Anti-Doping Policy will apply. Additionally, in any areas where the National Competition Rules and the CAMS Illicit Drugs in Sport (Safety Testing) Policy conflict, the CAMS Illicit Drugs in Sport (Safety Testing) Policy will apply.

ARTICLE M13 – POSTPONEMENT, ABANDONMENT OR CANCELLATION

The event may be abandoned, postponed or cancelled for reasons of force majeure in accordance with NCR 59 of the current CAMS Manual of Motor Sport.

ARTICLE M14 – PENALTIES

- Racing penalties shall be in accordance with the CAMS Motorkhana Code Section 17:

- K3.1 The Entrant (vehicle owner) shall provide written authorisation for the use of the vehicle in competition by the Driver(s) and acceptance of the Terms and Conditions by signing the disclaimer on the reverse of the entry form.
- K3.2 Vehicles shall be presented in a clean condition.
- K3.3 Mud flaps shall be fitted to all drive wheels to minimise track damage; guidance may be found in the current CAMS Manual of Motor Sport Schedule R.
- K3.4 Three different drivers may compete in the same vehicle with different numbers allocated.
- K3.5 Vehicles entered in the Khanacross are to comply with the current CAMS Manual of Motor Sport, General Requirements for Cars and Drivers Schedule A. All vehicles defined as special by Group 4H must comply with Motorkhana Cars – Group 4H requirements. This includes:
- Fire Extinguishers of min 900g (AS 1841 compliant) in accordance with Schedule H
 - Fuel in accordance with Schedule G
 - Seat belt/harness in accordance with Schedule I (including harness validity dates).

ARTICLE K4 – COMPETITOR ELIGIBILITY

- K4.1 The Event will be a multi-club activity and all entrants/competitors must be members of a CAMS-affiliated club.
- K4.2 Competitors must hold at least a CAMS Level 2NS or 2NSJ Competition Licence.
- K4.3 The minimum age is **14 years** for the Khanacross.
- K4.4 All competitors shall be suitably attired as per Schedule D of the current CAMS Manual of Motor Sport. This includes:
- Trousers to cover from waist to ankle
 - Suitable enclosed footwear (no thongs, sandals or high heels permitted)
 - Approved helmet fastened correctly (the helmet must comply with AS1698 or one that is specifically approved for use by CAMS and carries the markings to that effect)
 - In open cars, goggles or visors with lens of other than glass (AS1609-1981) must be worn
- K4.5 In addition, competitors shall have:
- Sleeves fastened to reach the wrist
 - Shirts done up from neck to wrist
 - Clothing and footwear of flammable synthetic material is not acceptable

ARTICLE K5 – CLASSES

- K5.1 Competitors will be graded into Categories at the discretion of the Organiser (minimum 5 entries for a category to be recognised):
- Grade 1 – All 4WD vehicles
 - Grade 2 – All 2WD

- K7.2 Vehicles entered in multiple events must submit their vehicles for scrutiny at each event.
- K7.3 All appropriate CAMS Licences, current club membership cards and CAMS vehicle logbooks (if issued) must be produced at Documentation at the times indicated in Article K2.
Note- CAMS licence renewals must be processed through the CAMS office and cannot be renewed on the day. New competitors only may purchase licences on the day.
- K7.4 Drivers entered in multiple events shall present for documentation at each event.
- K7.5 Drivers will not be allowed to commence reconnaissance and the event until their Scrutiny and Documentation is complete
- K7.6 Competitors are advised that any in-car video or moving film cameras must be installed in the vehicle prior to scrutiny so that the camera and its mounting can be inspected.

ARTICLE K8 – DRIVERS BRIEFING

A compulsory Drivers Briefing will be held as per Article K2. All competitors must be in attendance. Any competitor not in attendance must report to the Clerk of Course. Competitors will be required to have read and understood these Regulations and any further regulations or Advice and seek an Official if any further advice is required.

ARTICLE K9 – RECONNAISSANCE

- K9.1 Reconnaissance for the Khanacross event will be open to drivers unfamiliar with the tracks and will consist of an untimed, slow familiarisation of the each course in the set of tests. **Speed limit is 40km/h.**
- K9.2 Drivers shall complete Scrutiny and documentation prior to their reconnaissance runs.
- K9.3 All occupants of vehicles during the drive-through must be restrained in a car seat.

ARTICLE K10 – RUNNING OF THE EVENT

- K10.1 Only one car is permitted on the test at any one time. Cars will start from the left hand (or only) garage and shall complete the test in the left hand (in driving direction, or only) garage.
- K10.2 Timing will be by stopwatch.
- K10.3 After competitors have completed the first set of tests, the courses will be reversed and run again. This procedure will be repeated until the event concludes.
- K10.4 Each competitor in the Khanacross will have a minimum of 4 of timed runs, depending on competitor numbers and if time (daylight) permits.
- K10.5 Competition shall conclude at the dinner break.
- K10.6 Vehicles are limited to walking pace in the vicinity of the pits, race control and marshalling area **at all times**. Any individuals who fail to comply shall be referred to the Clerk of Course.

ARTICLE K11 – DETERMINATION OF WINNERS

- K11.1 The cumulative time for all timed runs (inclusive of penalties) prior to the dinner break shall be collated to determine results.
- K11.2 Any protest must be lodged in accordance with Part XII of the NCR. The Chief Timekeeper/Secretary will be the Judge of Fact.
- K11.3 The Khanacross event (day time only) will not be part of the 2014 BORMSA Club Championship.
- K11.4 No prizes shall be awarded for the Khanacross (day time only) event.

During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. - TK7.4 Drivers entered in multiple events shall present for documentation at each event.
- TK7.5 Drivers will not be allowed to commence reconnaissance and the event until their Scrutiny and Documentation is complete
- TK7.6 Competitors are advised that any in-car video or moving film cameras must be installed in the vehicle prior to scrutiny so that the camera and its mounting can be inspected.

ARTICLE TK8 – DRIVERS BRIEFING

A compulsory Drivers Briefing will be held as per Article TK2. All competitors must be in attendance. Any competitor not in attendance must report to the Clerk of Course. Competitors will be required to have read and understood these Regulations and any further regulations or Advice and seek an Official if any further advice is required.

ARTICLE TK9 – RECONNAISSANCE

- TK9.1 Reconnaissance for the Twilight Khanacross event will be open to drivers unfamiliar with the tracks and will consist of an untimed, slow familiarisation of the each course in the set of tests. Speed limit is 40km/h.
- TK9.2 Drivers shall complete Scrutiny and documentation prior to their reconnaissance runs.
- TK9.3 All occupants of vehicles during the drive-through must be restrained in a car seat.

ARTICLE TK10 – RUNNING OF THE EVENT

- TK10.1 Only one car is permitted on the test at any one time. Cars will start from the left hand (or only) garage and shall complete the test in the left hand (in driving direction, or only) garage.
- TK10.2 Timing will be by stopwatch.
- TK10.3 After competitors have completed the first set of tests, the courses will be reversed and run again. This procedure will be repeated until the event concludes.
- TK10.4 Each competitor in the Twilight Khanacross will have a minimum of 8 of timed runs, depending on competitor numbers and if time permits.
- TK10.5 Vehicles are limited to walking pace in the vicinity of the pits, race control and marshalling area at all times. Any individuals who fail to comply shall be referred to the Clerk of Course.

ARTICLE TK11 – DETERMINATION OF WINNERS

- TK11.1 The cumulative time for all timed runs (inclusive of penalties) on Khanacross tests shall be collated to determine results.
- TK11.2 Any protest must be lodged in accordance with Part XII of the NCR. The Chief Timekeeper/Secretary will be the Judge of Fact.
- TK11.3 The Twilight Khanacross event comprises part of the 2014 BORMSA Club Championship. For outright competitors, points will be scaled from 1st place to 15th place as per the following for 2WD cars: 20, 17, 15, 13, 11, 10, 9, 8, 7, 6, 5, 4, 3, 2, 1. Points for 4WD cars are as above but minus 8 points. ie. 12, 9, 7, 5, 3, 2, 1.
- TK11.4 Point shall be allocated to all competitors, however, to be eligible for the Club Championship, competitors must be BORMSA members. To register a result for the Championship, a competitor must officiate/volunteer at a minimum of one event per year (excluding juniors).
- TK11.5 The winner of the Twilight Khanacross event (as determined in K11.1) shall receive a BORMSA voucher to the value of \$45. A second \$45 BORMSA voucher shall be awarded from a raffle of all entered competitors (including non-finishers) and signed-on officials.

ARTICLE TK12 – USE OF PROHIBITED SUBSTANCES

During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A and 145B of the CAMS Manual of Motor Sport. In addition, the persons concerned will be subject to the articles of the Standard Operating Procedure for Alcohol Testing, the CAMS Anti-Doping Policy and the CAMS Illicit Drugs in Sport (Safety Testing) Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s). **Other Prohibited Substances:** the CAMS Anti-Doping Policy, as appears in the CAMS Manual of Motor Sport, and as amended from time to time, recognised as an integral component of the NCR and is duly authorised as such. In any areas where the National Competition Rules and the CAMS Anti-Doping Policy conflict, the CAMS Anti-Doping Policy will apply. Additionally, in any areas where the National Competition Rules and the CAMS Illicit Drugs in Sport (Safety Testing) Policy conflict, the CAMS Illicit Drugs in Sport (Safety Testing) Policy will apply.

ARTICLE TK13 – POSTPONEMENT, ABANDONMENT OR CANCELLATION

The event may be abandoned, postponed or cancelled for reasons of force majeure in accordance with NCR 59.

ARTICLE TK14 – PENALTIES

- Racing penalties shall be in accordance with the CAMS Khanacross Regulations Section 14.
