#### 9 GENERAL BUSINESS

#### 9.1 Autocross

Paying of Officials was decided as a good incentive and to keep it going into 2013. Discussion about the timing system set up being a remote controlled system, operating with the same starting lights, but different display clocks. It will be an easier system as it is a wireless system and can be connected directly into a computer.

#### 9.2 Entries

Entries are to be continued to be limited to 40 for Khanacrosses (multi-club) and Autocrosses (club only). Junior Motorkhanas and Driver Developments days remain unchanged at a 20 entry limit.

#### 9.3 Calendar for 2013

The 2012 calendar dates were previously nominated and set.

Sat 20 April: Busy Bee / Junior Motorkhana

Sun 21 April: Khanacross

Sun 2 June: Autocross / Junior Motorkhana

Sat 6 July: Khanacross

Sun 7 July: Junior Motorkhana / Drive Day / Busy Bee

Sat 3 August: Twilight KX Sun 4 August: Autocross

Sun 15 September: Autocross/Junior Motorkhana

Sat 26 October: Twilight KX Sun 27 October: Autocross

The website is to be updated accordingly with all proposed event dates. Consideration will be made during the year to add or remove events dependant upon the weather and also having enough officials being available to run them. An experienced driver training day / shakedown in late March prior to the rally season may also be considered (also weather dependant).

# 9.4 Fees

Continue attempts to have entrants to pre-book for catering purposes on their entry form with notification on Supp Regs to inform cometitors to advise.

Track hire (commercial events) \$800/day (limit of 10 cars)

Track hire (long term club members 3 years+) \$200 + \$100 per additional vehicle
Track hire (non members & club members less than 3 years) \$300 + \$150 per additional vehicle

Track hire (other clubs, khanacross event) \$10/car Track hire (other clubs, motorkhana event) \$5/car

Contributing Office Bearers and Committee members will receive complimentary membership.

#### 9.5 Tracks

Concerns raised with the state of the lower Khanacross tests. BORMSA Committee to review existing tracks and opportunities for new Khanacross tracks.

#### 9.6 Newsletter and Website

Newsletters issued throughout the year, Cheryl will aim to issue every 3-4 months in 2013. Members requested to send photos from events.

BORMSA website operating smoothly apart for some downtime during the year. Website hosting will be discussed between Mark Davies and Darryn Picen with a view to possibly move the BORMSA site host location.

## 9.7 Club Championship

Points structure and trophies for 2013 will remain as per 2012.

To be eligible for points and trophies, drivers must be BORMSA members, have competed in a minimum of 2 events and, apart from juniors, must have officiated or assisted in running an event to be eligible for trophies.
